This ArcGIS® for Schools Bundle Summary (the "Summary") is a handy reference for Esri Schools and Clubs licensees and subscribers that summarizes some of the more important terms and conditions from the Esri Master Agreement.

This Summary is not intended to be a license agreement and is provided as a convenience and quick start for the Esri Schools and Clubs licensees and subscribers. The terms and conditions of the Esri Master Agreement control and take precedence over this Summary. 1. Definitions

- a. "ArcGIS for Schools Bundle"—A collection of online and desktop GIS applications, plus data, as described at esri.com/schools, includes member-generated content licensed for instructional use only.
- b. "Schools"—Public and private schools covering grades K-12 (primary and secondary); precollegiate instruction, including academies, technical schools, magnet schools, charter schools, religious schools, online schools, home schools, and the like; and collections of schools such as districts, divisions, parishes, cooperatives, and the like.
- c. "Clubs"—Formal youth-serving clubs such as 4-H, Future Farmers of America (FFA), scouts, and the like.



2. Eligible Organizations

- a. Esri offers the ArcGIS for Schools Bundle to eligible institutions at no cost for instructional use. This includes the following:
 - I. Schools and clubs providing formal or informal instruction to K-12 students
 - II. Higher education institutions providing instruction to K-12 students, or in-service or preservice teachers of K-12 students
 - III. Organizations providing not-for-profit instruction or content exclusively for the instructional use of K-12 students or teachers of K-12 students





3. Eligible Users

- a. Students registered at a licensed institution (includes recent high school graduates continuing instruction or archiving their past content) and recognized or pending Club members
- b. Teachers, staff, or other adult leaders officially employed or engaged by a licensed organization
- c. Outside mentors recognized by license administrators to assist in instruction or content development



4. Uses Permitted

- a. Noncommercial instructional use with K-12 students in pursuit of a high school diploma or Club-recognized goal, including academic exercises and skill-building activities
- b. Noncommercial service activities to support K-12 student instruction (i.e., where the student is the prime beneficiary; turning over student products is not a condition for student participation)



5. Uses Not Permitted

- a. Administrative use (i.e., noninstructional such as bus routing, safety mapping) by the School or Club
- b. Commercial activities (e.g., freelance or managed work for hire, not driven by advancing a student toward a diploma; most internships fall in this category)
- c. Personal activities not related to students building toward a high school diploma
- d. Posting content that violates anyone's privacy or encourages conduct that would constitute a criminal offense, give rise to civil liability, or otherwise violate any law or regulation



6. Commitments

- a. Schools and Clubs commit not to use, transmit, or store personally identifiable information ("PII") of minor children/students through the use of the ArcGIS for Schools Bundle. Schools and Clubs are responsible for any use of PII on Esri systems and for instructing teachers and members why and how to avoid the use of such PII data. Schools and Clubs are free to generate and store their user-generated content, but it is the School's and Club's responsibility to ensure that no PII of minor children/students is included in their user-generated content.
- b. Schools and Clubs are responsible and liable for any unauthorized conduct occurring under the licenses or subscriptions.
- c. Esri offers and only accepts its pre-signed Data Processing Addendum (DPA) to support the ArcGIS for Schools Bundle.
