Why: This is a new footnote to support Esri's new Products ArcGIS Indoors Maps, ArcGIS Indoors Spaces, and ArcGIS IPS. Value-Added Applications built for use with user types provided with ArcGIS Indoors Maps cannot be built to use capabilities outside of those described in this Footnote 100.
