Date of Update Implementation: April 1, 2025

Overview: The Product Specific Terms of Use (E300), have been updated to reflect changes due to updated Esri policies, and clarification language derived from Esri Product Management and customer requests.

Sections(s) Impacted: Impacted with contextual, clarification, grammar, or terms & Conditions changes, which will impact future version use.

General Changes: *Most changes are grammatical changes or updates to wording to allow for better flow of what the statement is supposed to imply. Major changes described below.*

Why: Adding ArcGIS Pro due to the addition of FN 7 to further clarify permitted use.

Why: ArcGIS Maps SDKs for Flutter is part of the ArcGIS Maps SDKs for Native Apps family.

For ArcGIS StreetMap Premium North America 2024 Release 2, ArcGIS StreetMap Premium Europe 2024 Release 1, ArcGIS StreetMap Premium Latin America 2024 Release 1, ArcGIS StreetMap Premium Asia Pacific 2024 Release 1, ArcGIS StreetMap Premium Middle East & Africa 2024 Release 1, or their subsequent releases, real-time navigational guidance, synchronized multi-vehicle routing and synchronized route optimization is permitted, except as follows: (i) in-vehicle systems integration (e.g. vehicle sensors, driver assistance, autonomous vehicles); or (ii) Value-Added Applications/Customer Applications whose purpose is to target consumers for the primary purpose of providing real-time routing and/or navigation.

Why: Updating FN 6 to include applicable version releases for Middle East and Africa. Also accurately updating the product name.

7. Customer is not permitted to run scheduled operations (i.e., batch processing) on more than one machine when logged in with a Named User license.

78-10. Reserved

Why: Adding FN 7 to further clarify Customers can use ArcGIS Pro on multiple computers, as outlined in the Documentation, with a Named User license, however, the intent of allowing this is not for batch processing and running multiple tasks unattended.

83. Customer must use a separate ArcGIS Project Delivery Subscription for each Customer client ("Client"). Customer may use the ArcGIS Project Delivery Subscription (i) solely to collaborate on project work with its Client; (ii) sub-license the Named User License(s) to Client and any third-parties ("Stakeholders"), identified by the Client as representing the Client in any project, to collaborate on project work that Customer performs for the sole benefit of the Client. Client and Stakeholders may not use the Named User License(s) for any other purpose. Customer is solely responsible for Client's and Stakeholders' compliance with these terms of use and will ensure that Client and Stakeholders stops using the ArcGIS Project Delivery Subscription when thea project ends.

Why: Updating FN 83 to add additional clarifications. A Stakeholder may also be granted access to a Named User License. Additionally, changing "the" to "a" as a Project Delivery Subscription can be used for multiple projects for the same Client.
