Product Description: ArcGIS Velocity is a real-time and big data processing and analysis capability of ArcGIS Online that enables users to ingest, visualize, and analyze spatial real-time and big data to gain new insights and take action.

Explore your streaming IoT data on maps and dashboards, identify temporal patterns, and extract location-based intelligence — all while working at scale in the geospatial cloud. Smart cities, federal agencies, utilities, transportation, oil and gas, and retail customers can start leveraging spatial big data to gain real-time visibility into day-to-day operations and make efficient decisions based on increased situational awareness.

Notes: This product does not contain any prerecorded or live audio-only and video-only content.

Evaluation Methods Used: Testing ArcGIS Velocity involved a combination of manual and functional testing on desktop. The product was tested by certified accessibility professionals on a selection of the application representative of ArcGIS Velocity using, among other methodology, the screen reader JAWS 2024, exclusive use of the keyboard, and manual inspection of code. Functional testing of typical user workflows was also conducted.

Purpose

Software
